BREED EXAMS

As stated in the April 2012 JEC newsletter, Judging Operations has created truncated versions of the breed exams. These exams will not be posted on the AKC Website and are only available by contacting the Judging Operations Department. Please advise all presenters to contact Judging Operations for the exams. Please note, if the presenter neglects to supply the exam, the club or the organization hosting the judge's education seminar is required to

supply the exam to attendees at the seminar. Presenters are encouraged to contact Judging Operations with any questions regarding the administering of the exams. Upon completion of the seminar all documentation must be submitted to Judging Operations by regular mail.

Please remind attendees, in order to receive credit for attending, a breed seminar the exam must be taken and a passing grade achieved, even if the attendee has previously taken the exam.

SEMINAR OR CLINICS

At its October 2012 meeting, the Board of Directors approved a recommendation to modify the Occupational Eligibility Addendum. This addendum is an interpretation of Chapter 7, Section 1, of the Rules Applying to Dog Shows, first adopted by the Board in 1991 and part of the Judging Approval Process since 1992.

The specific item addressed pertained to the restriction that individuals were not permitted to present dog-related seminars or clinics at shows, circuits or clusters in which they were judging until the completion of all judging assignments.

As a result of the October 2012 meeting, this restriction previously found under Section II, "Individuals with the following occupations will be eligible to judge, but cannot accept assignments at any show, companion show, circuit or cluster at which

they offer their services," was eliminated effective immediately.

Judging Operations strongly advises that individuals who conduct a seminar, clinic, or workshop in a breed they are scheduled to judge following their presentation should not utilize any dogs entered under them as examples of that breed or in the hands-on workshop if offered.

The Occupational Eligibility Addendum has been revised to reflect the recent modification approved by the Board and can be viewed on the AKC website at http://www.akc.org/pdfs/rjloo1.pdf.
